This letter is to inform you of the availability of the Responses to Comments document for the Significant Natural Resources Area Management Plan (SNRAMP or Natural Resources Management Plan). You are being sent this letter because our records indicate that you commented on the Draft Environmental Impact Report or you have requested to be notified of actions relating to environmental review for this project.

The Responses to Comments document, in combination with the Draft EIR, constitute the Final EIR for the proposed project. This Final EIR contains information about the possible environmental effects of the proposed project. Preparation of an EIR does not indicate a decision by the City to carry out or not to carry out the proposed project. **This document, along with the Draft EIR, will be before the Planning Commission for Final EIR certification on December 15, 2016.** The Planning Commission will receive public testimony on the Final EIR certification at the December 15, 2016, hearing. Please note that the public review period for the Draft EIR ended on June 11, 2012. With respect to any comments received after the close of the public comment period for the Draft EIR, there is no obligation on the Planning Department's part to respond to such comments in writing, including any comments provided orally or in writing at the Final EIR certification hearing.

The Planning Commission does not conduct a hearing to receive comments on the Responses to Comments document, and no such hearing is required by the California Environmental Quality Act. Interested parties, however, may always write to Commission members or to the President of the Commission at 1650 Mission Street and express an opinion on the Responses to Comments document, or comment on the Commission's decision regarding whether to certify the completion of the Final EIR for this project.
