PROJECT DESCRIPTION:

The project proposes to construct a new four-story, six-unit residential building with three stories of residential over ground floor parking on a vacant paved site. The new building would feature four two-bedroom units and two one-bedroom units, with a total of 7,724 square feet of residential space. The existing Hotel Tomo parking in the basement level beneath the subject site would be preserved. The resulting structure would be 9,898 square feet in area and 40 feet in height. The proposal includes five off-street parking spaces, three protected bicycle racks, and one bicycle storage space for a total of seven Class 1 bicycle parking spaces.
